Call to order - Betty

City update - Betty

On July 5 Betty, Dave and Steve met with city representatives Rob McAulay and Chris Kawalec to discuss PLBC's proposal. The City is proposing an arrangement whereby the City would absorb the property into its Peterborough Sport and Wellness Centre operations, staffing and covering the cost of operating the facility and parking areas for its sports development and seniors programs. We have advised our lawyer John Ewart of our meeting with the City and plan to meet with him once we receive the City proposal.

- 2. Update re: F&F tournament Sally
- Will go with The Shed caterers as they had the best price. Meal is lasagna and salad. Laurie, Sally and Betty will bring dessert. Sally will pick up buns and bottled water.

- 3. Greens and Property

Knights of Columbus - Hall rental \$175-275 (depending on size of room). Table set up is \$40. Bar available. We would need to get a caterer.

Personal Touch - too pricy

Decision by board to have dinner at club. If we wan to serve alcohol we need to obtain an event license. Should be looked into now as it can take a few weeks to get one.
